

AMENDMENT TO FULTON COUNTY REVISED ORDINANCE OF LIQUOR CONTROL

WHEREAS On April 12, 1977 the County Board of Fulton County, Illinois passed and approved, "Fulton County Revised Ordinance of Liquor Control", Known as the "Alcoholic Liquors Resolution", in order to license, tax and to regulate the sale and retail of alcoholic liquors in the territory of the County outside the corporate limits of any city, town or village; and,

WHEREAS, the aforesaid "Fulton County Revised Ordinance of Liquor Control" has also been amended on June 13, 1977; on December 27, 1982; on June 13, 1989; on December 10, 1992; on May 13, 2003; on February 10, 2004; and on October 10, 2006; and,

WHEREAS, the "Fulton County Revised Ordinance of Liquor Control", as amended, has set out under Section V three Classes of licenses and has further set out license fees for the three separate classes of licenses and the due date for paying for the licenses; and,

WHEREAS, it has been recommended that a portion of the "Fulton County Revised Ordinance of Liquor Control", as amended, be further amended to allow a grace period for paying the complete licensing fee for the license period of July 1, 2020 through June 30, 2021.

NOW THEREFORE BE IT ORDAINED BY THE COUNTY BOARD OF THE COUNTY OF FULTON THAT THE FULTON COUNTY REVISED ORDINANCE OF LIQUOR CONTROL AS AMENDED IS AMENDED TO INCLUDE THE FOLLOWING SECTION V-A WHICH SHALL FOLLOW SECTION V AND PRECEED SECTION VI OF THE FULTON COUNTY REVISED ORDINANCE OF LIQUOR CONTROL AS FOLLOWS:

SECTION V-A

On June 30, 2020 the following establishments hold a Class A or Class B Liquor license issued pursuant to Section V of this Ordinance which will expire on that day:

1. Lake Bar and Grill
2. Scapecchi's Supper Club, Inc.
3. Orchard Hill Farm, LLC
4. Native Trails Winery, Inc.
5. Sean's Tap, Inc.
6. Big Horse Vineyards, LLC
7. Big Horse Wines, LLC.

8. Wee Ma Tuk Partners, Inc.
9. Wood'zs G&Z Inc. Sky Rocket Tap
10. Bernadotte Café, Inc.
11. Morrell's Package Liquors

That the obligation set forth in Section V of this Ordinance requiring that "All Licenses issued as of July 1, 2003 and thereafter, shall be payable in advance", shall not be in effect for the licensing period of July 1, 2020 through June 30, 2021 for the 11 establishments set forth above. That for the licensing period of July 1, 2020 through June 30, 2021, the 11 establishments set forth above shall be obligated to pay at least 5% of the annual rate license fee described in Section V of this Ordinance in advance of the issuance of a July 1, 2020 through June 30, 2021 license, and the remainder of each establishment's annual rate license fee shall be paid by October 1, 2020. Failure of any of the 11 establishments described in this Section V-A to pay the remainder of the annual rate fee described in this paragraph by October 1, 2020 shall be considered good cause for the Chairman of the Fulton County Board to suspend or revoke an establishment's local license pursuant to 235 ILCS 5/4-4(1).


Further, that this Section V-A of the Fulton County Revised Ordinance of Liquor Control, as amended, shall be a valid Ordinance from the day of its Adoption by the Fulton County Board and shall continue in effect until June 30, 2021, at which time it shall expire.
