- Looking at the region (Fulton County is in IDPH Region 2), 6% of ICU beds are available. This is a total of 15 ICU beds out of 231. This is a slight decrease of available beds.
- All deaths in Fulton County in the past 60 days related to COVID-19 were unvaccinated.
- *Nationwide* 62.6% of the population is fully vaccinated. 71.5% of those 12 years of age and older are vaccinated. Approximately 36.5% of the vaccinated US population has received a booster dose which is an increase of 5% in the past 11 days.
- Approximately one third of all ICU Beds in the state of Illinois are occupied by COVID
 Patients. Approximately 7,114 people are in the hospital (this excludes the ICU) with
 COVID-19 which is approximately 29% of non-ICU beds in hospitals.
- Spoon River College and Graham Hospital are working together on an expanding testing initiative. That information is attached to this briefing.
