	OPDINANCE TO RESTRICT TRUCK	TRAFFIC ON COUNTY HIGHWAYS

IT IS HEREBY ORDAINED by the County Board of Fulton County, Illinois that the statutory maximum vehicular weight limits established by 625 ILCS5/15-11 and LRB096 03503 HLH 13528 of the Illinois Vehicle Code are greater than that considered reasonable on County Highways in Fulton County; and,

BE IT FURTHER ORDAINED that, this shall take effect immediately after the erection of signs giving notice of such restrictions. Said signs shall be erected in conformance with the standards and specifications contained in the Illinois Manual on Uniform Traffic Control Devices for Streets and Highways.

BE IT FURTHER ORDAINED that, the following roads will be posted in a manner to maintain a maximum load of 73,280 pounds in gross weight and to enforce the provision of LRB 096 allowing a sign be posted to prohibit excessive loads (as indicated in **PURPLE** on Exhibit 1):

Any person, firm, or corporation convicted of violating this Ordinance shall be fined \$500 for the first offense and \$1,000 for each subsequent offense.
