RESOLUTION

WHEREAS Fulton County, Illinois has been granted authority to regulate and restrict location and use of structures pursuant to 55 ILCS 5/5-12001 et. seq. and to amend its' zoning regulations by resolution pursuant to 55 ILCS 5/5-12013, and

WHEREAS, the Fulton County Zoning Office regularly issues conditional use permits for Solar Energy Systems, Wind Energy Systems and Battery Energy Storage Systems inside of Fulton County, and

WHEREAS, the Fulton County Zoning Office regularly issues Zoning, Construction, and Building permits for Solar Energy Systems, Wind Energy Systems and Battery Energy Storage Systems inside of Fulton County, and

WHEREAS, these permits require an investment of time and effort in procuring information and documenting their compliance, and

WHEREAS, it is the recommendation of the Community Development Committee of the Fulton County Board that Appendix A of the 2009 Fulton County Zoning Ordinance be amended to reflect that the fees for Conditional Use Permits for Solar Energy Systems, Wind Energy Systems and Battery Energy Storage Systems inside of Fulton County be in the amounts set forth in Exhibit A attached hereto and made a part hereof by reference; and

WHEREAS, it is the recommendation of the Community Development Committee of the Fulton County Board that Appendix A of the 2009 Fulton County Zoning Ordinance be amended to reflect that the fees for Zoning, Construction, and Building Permits for Solar Energy Systems, Wind Energy Systems and Battery Energy Storage Systems inside of Fulton County be in the amounts set forth in Exhibit A attached hereto and made a part hereof by reference.

WHEREFORE. IT IS RESOLVED AND ORDERED by the Fulton County Board that Appendix A of the 2009 Fulton County Zoning Ordinance be amended to reflect that the fees for Conditional Use Permits for Solar Energy Systems, Wind Energy Systems and Battery Energy Storage Systems inside of Fulton County be in the amounts set forth in Exhibit A attached hereto and made a part hereof by reference.

That Appendix A of the 2009 Fulton County Zoning Ordinance be amended to reflect that the fees for Zoning, Construction, and Building Permits for Solar Energy Systems, Wind Energy Systems and Battery Energy Storage Systems inside of Fulton County be in the amounts set forth in Exhibit A attached hereto and made a part hereof by reference.

The fees set forth in this resolution shall supersede any previous fees related to Solar Energy Systems, Wind Energy Systems and Battery Energy Storage Systems.
