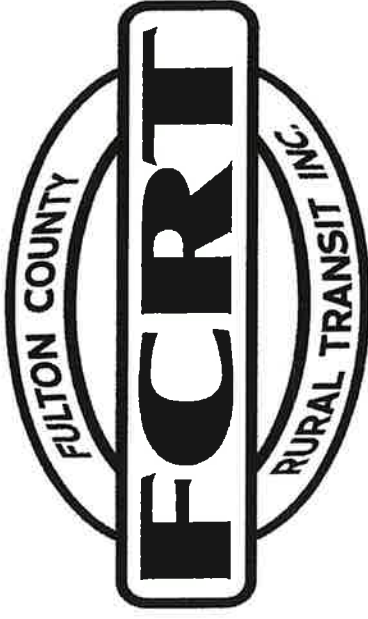

Tips and Rules

- Passengers are encouraged to be ready (15) fifteen minutes prior to scheduled pick up time.
- Passengers must pay at boarding time.
- Cancellations are to be made in a timely manner, preferably 24 hours in advance.
- Passengers must provide their own mobility aids.
- All passengers are required to wear seat belts.
- One personal attendant per passenger will be allowed at no charge if need is determined.
- Children under the age of 17 years old must be accompanied by an adult.
- Children under the age of 8 years old must be seated in the appropriate child safety seat.
- Child safety seat must be provided by the passenger.
- No pets allowed on the vehicle except for service animals.
- No smoking, eating, drinking, foul language, harassment, weapons, illegal drugs or open alcohol is allowed on the vehicle.
- Passengers participating in inappropriate behavior on the vehicle may be denied service.

(per hour) wait fee

- Senior citizens 60 years of age or older and persons with disabilities ride for half price.
- No discounts apply to the wait fee.
- Fares are to be paid to the driver at the beginning of the ride.
- Passengers are encouraged to have exact fares.
