The major Taxing Bodies in Illinois are School Districts, Counties, Municipalities, Townships and Special-Purpose Districts. The majority of Special-Purpose Districts include, but are not limited to, Park, Library, Fire Protection, Sanitary/Sewer, and more.

Property taxes in IL are calculated by multiplying your property's Equalized Assessed Value (EAV), minus exemptions, times the total local tax rate. Formula **(EAV - Exemptions) X Tax Rate = Tax Bill** The EAV is typically 33 1/3% of your home's fair market value, adjusted by a state-mandated multiplier.

Pursuant to 35 ILCS 200/21-135, the collector shall collect \$10 from the taxpayer to cover the costs of registered or certified mailing and the costs of advertisement and publication.

Pursuant to 35 ILCS 200/21-15, for property located in a county with fewer than 3,000,000 inhabitants, the unpaid taxes shall bear interest at the rate of 1.5% per month, or portion thereof. If paying late, please make sure to include the interest penalty in your payment. The payment scale on each installment stub includes the proper penalty amounts to be paid for each date range.

Effective Dec, 24, 2025, mail is postmarked when **processed** not dropped off. USPS recommends you take items to a Post Office counter and request a hand-stamp for the correct date or send **several** days before the deadline.

Did you know...

You can pay online or over the phone using the E-check method and it costs only \$1.50. For your convenience, this feature is available 24 hours a day/7 days a week until September 30th.

Pursuant to 35 ILCS 200/20-25, a county collector may refuse to accept a personal or corporate check within 45 days before a tax sale.

DID YOU KNOW?

- This is the only property tax bill you will receive. This bill includes a separate payment stub for each installment to be included with your payment.
- Failure to receive a tax bill or receiving one late, for any reason, will not relieve the property owner from the responsibility of paying taxes, penalties, or fees.
- Illinois law provides that all taxes not paid by due date shall have interest added at the rate of 1 1/2% per month until paid or sold at tax sale.
- If tax, interest, or costs remain unpaid, application will then be made to the Circuit Court for Judgement and order of sale against the property. If Sold, interest (up to 9%) will be added for each six months of fraction thereof.

- Any exemptions you are currently receiving are noted on the front of your tax bill. Ways to possibly reduce YOUR equalized assessed valuation (EAV):
 - OWNER OCCUPIED - UP TO 6,000
 - SENIOR CITIZEN'S ASSESSMENT FREEZE
 - DISABLED VETERAN
 - DISABLED PERSON - UP TO 2,000
 - SENIOR HOMESTEAD - UP TO 5,000
 - HOME IMPROVEMENT EXEMPTION
 - RETURNING VETERAN - UP TO 5,000

It is important to check your tax bill every year for exemptions that you may qualify for.
